### OBITUARY REFERENCES

MR. CHAIRMAN: Hon. Members, with profound grief, I refer to the passing away of renowned *tabla* maestro, Ustad Zakir Hussain, on 15<sup>th</sup> December, 2024. Born on 9<sup>th</sup> March, 1951 in Mumbai, Ustad Zakir Hussain transcended the boundaries of art and culture, elevating Indian music to global prominence. As an iconic ambassador of Indian classical music, he bridged cultural divides, bringing the rich traditions of Indian percussion to the global stage. His extraordinary contributions were widely recognised, including through the awards Padma Shri in 1988, Padma Bhushan in 2002 and Padma Vibhushan in 2023. In a historic moment in 2024, he became the first Indian artist to win three Grammy Awards in a single night, cementing his place in the pantheon of global musical greatness. Forever remaining a student of music, *that is in his own words*, Ustad Zakir Hussain, is leaving behind a legacy of unmatched artistry and humility. His contributions will continue to inspire future generations of musicians and music lovers alike. With his passing, India has lost a true musical genius, but he will forever be remembered by all who were touched by his enchanting music.

I request all the Members to rise in their places and observe a moment of silence as a mark of respect to his enduring memory.
