**SOCIO-ECONOMIC DEVELOPMENT OF TRIBALS IN CHHATTISGARH**

1514. SMT. PHULO DEVI NETAM:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the details of different programmes being run at present in the Chhattisgarh tribal areas with the cooperation of the Central Government;
- (b) the schemes implemented for socio-economic development of Scheduled Tribes in the State during the last five years;
- (c) the amount allocated to Chhattisgarh Government by the Union Government under the above schemes during the last five years;
- (d) the amount utilized and unutilized by the State Government released under the above schemes during the above period;
- (e) whether Government has implemented any new scheme for Scheduled Tribes; and
- (f) if so, the details thereof?

**(e) & (f):** Yes. The Hon'ble Prime Minister of India launched Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) on 15th November 2023. The mission aims to provide basic facilities like safe housing, clean drinking water and improved access to education, health and nutrition, road and telecom connectivity, electrification of unelectrified households and sustainable livelihood opportunities in 3 years. These objectives are being met through 11 interventions implemented by 9-line Ministries.

The Hon'ble Prime Minister of India launched Dharti Aaba Janjatiya Gram Utkarsh Abhiyan on 2nd October, 2024. The Abhiyan comprises 25 interventions implemented by 17 line Ministries and aims to saturate infrastructural gaps in 63,843 villages, improved access to health, education, Anganwadi facilities and livelihood opportunities benefiting more than 5 crore tribals in 549 districts and 2,911 blocks in 30 States/UTs including Chhattisgarh in 5 years.
