E-GRAMSWARAJ

1527. SHRI BANSHILAL GURJAR:

Will the Minister of PANCHAYATI RAJ be pleased to State:

(a) the details of the implementation and adoption status of the e-GramSwaraj initiative, launched in April 2020 to improve the functioning of Panchayats;

(b) the number of Gram Panchayats that have uploaded their Gram Panchayat Development Plans (GPDs) on the e-GramSwaraj platform for the financial year 2023-24;

(c) the percentage of the total Gram Panchayats that are currently using the e-GramSwaraj platform in the country, along with the measures being taken by the Ministry to promote its adoption among the remaining panchayats; and

(d) whether any future reforms or additional features are planned to further strengthen the functionality of Panchayats improve governance for the e-Gram Swaraj platform?

ANSWER

THE MINISTER OF STATE FOR PANCHAYATI RAJ

(PROF. S.P. SINGH BAGHEL)

(a) Under the Digital India Programme, the Ministry of Panchayati Raj is implementing the e-Panchayat Mission Mode Project (MMP) across all States and Union Territories (UTs) of the country. This initiative aims to revamp the functioning of Panchayats, making them more transparent, accountable, and effective. As part of this initiative, the Ministry has launched eGramSwaraj, an online planning and accounting application designed to simplify Panchayat activities such as planning, accounting, and budgeting. The Ministry has also integrated eGramSwaraj with the Public Financial Management System (PFMS) for Gram Panchayats (GPs) to make real time payments to vendors/service providers. Panchayats use the eGramSwaraj portal to prepare and upload their Annual Panchayat Development Plans. The progress made by States/UTs under eGramSwaraj for the 15th Finance Commission during the year 2024-25 is provided in **Annexure-I**.

(b) State wise details of Gram Panchayats that have uploaded their Gram Panchayat Development Plans (GPDs) on the e-GramSwaraj platform for the financial year 2023-24 is provided in **Annexure-II**.

(c) The percentage of the total Gram Panchayats that are currently using the e-GramSwaraj platform in the country is given at **Annexure-I**. Further, the Ministry constantly

engages with the States/UTs through virtual and physical training and enablement for States to adopt the eGramSwaraj application. All States are making efforts to implement e-Panchayat MMP, based on their available resources. However, due to differentials in the level of preparedness of Panchayats across the country, States are at different stages of implementing these applications.

(d) The Ministry is continuously enhancing the e-Panchayat Mission Mode Project (MMP) by addressing bottlenecks based on feedback from States and Union Territories. Necessary modifications are being incorporated to improve the functionality of e-GramSwaraj, along with capacity-building initiatives to strengthen digital literacy among Panchayat officials for better platform utilization.
