PM JANMAN FOR PVTGs

2213 SHRI SANDEEP KUMAR PATHAK:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the list of PVTGs and their numbers State-wise/UT-wise for which PM JANMAN had been announced;
- (b) the primary or secondary survey/research/census/ study by which these PVTGS have been identified in each State/UT and the year of conduct of survey, share the report, if any; and
- (c) fund allotted & spent under PM JANMAN for each State/UT for the financial year 2023-24 to 2025-2026, year wise; and
- (d) the details of major development/welfare activities undertaken under this Abhiyan in each State/UT?

ANSWER

(a): 75 tribal have been identified as Particularly Vulnerable Tribal Groups (PVTGs) residing in 18 states and one UT. The list of PVTGs is at **Annexure-I**. In view of the implementation of PM JANMAN, the Ministry of Tribal Affairs through the State Governments/ UT Administration/departments has undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG population residing in villages & habitations under PM JANMAN. Based on the data captured (as on 28.02.2025), the number of PVTGs, State/UT- wise, are tabulated at **Annexure-II**.

(b): Ministry of Tribal Affairs was set up in 1999. Before that in 1985-86, the erstwhile Tribal Development Division was moved from the Ministry of Home Affairs to Departments of Welfare. Later Ministry of Tribal Affairs was curved out of Tribal Development Division of Ministry of Social Justice and Empowerment. As per information available in this Ministry, Dhebar Commission was set up under Article 339 of the Constitution in April 1960, which were assigned various tasks of investigation and reporting problems of STs. The Commission in its report in 1961 observed that amongst tribals, lowest layer needs the utmost consideration at the hands of the Government. Accordingly, during the Fifth Five Year Plan period, in consultation with the State Governments, 52 groups were identified as Primitive Tribal Groups (PTGs) and subsequently, other

tribal groups (23) were added in the category, bringing the total number to 75. PTGs were later renamed as Particularly Vulnerable Tribal Groups (PVTGs). The National Advisory Council had also noted in its report that the 75 PVTG communities are categorised based on criteria namely a forest-based livelihood, a subsistence economy; extremely low literacy; pre-agricultural level of existence; and a stagnant or declining population. (c) & (d): Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) has total budgetary outlay of Rs.24,104 Cr (Central share: ₹15336 Cr and State share: ₹8768 Cr). As per Expenditure Profile 2025-2026 of GoI, Actual for 2023-24 under the abhiyan were 1367.30 Cr, for 2024-25 (RE) an amount of Rs.4903.91 Cr has been allocated and Rs.6351.99 Cr has been allocated (BE) for FY 2025-26. The release of funds to States/UT is subject to scheme guidelines of various schemes under the mission, submission of proposals by respective State Government/UT and compliances of General Financial Rules (GFRs) etc. Details of financial progress, Ministry-wise & State-wise, under the Abhiyan are at **Annexure-III**.
