DBT for fertilizer subsidy

191. SHRI S. SELVAGANABATHY:

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) whether the Government has finalized the Direct Benefit Transfer (DBT) model for fertilizer subsidy to farmers and if so, the details thereof;
- (b) whether the Government has undertaken any consultations for implementation of the said model and if so, the details thereof;
- (c) the number of farmers and farming households in the country who have received Direct Benefit Transfer of fertilizer subsidy since 2018 till date, State/ UT-wise; and
- (d) the total amount of funds disbursed in this regard, State/UT-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS

(SMT. ANUPRIYA PATEL)

(a) & (b): Government of India after due consultation has implemented Direct Benefit Transfer (DBT) in Fertilizers across all States/UTs with effect from March, 2018. Under the DBT system, the sale of subsidised fertilizers is on the basis of Aadhaar authentication of buyers and the subsidy is paid to Fertilizer Companies on the basis of actual sales made by the retailers to the beneficiaries through Point of Sale (PoS) devices installed at each retailer shop.

(c): Based on the available data, the State wise, year wise number of unique buyers/beneficiaries who have purchased subsidized fertilizers from 2019-20 to till 30.01.2025 is placed at **Annexure 'A'**.

(d): The State wise, year wise total amount of funds disbursed in this regard from 2018-19 till 30.01.2025 is placed at **Annexure 'B'**.
