FUNDS OWED BY THE CENTRE TO STATES

251. SHRI RITABRATA BANERJEE:

Will the Minister of **FINANCE** be pleased to state:

- a) whether the Central Government owes to State Governments huge sums of money under PMAY, MGNREGA, National Health Mission, PM Gram Sadak Yojna, Swachh Bharat Mission, Mid-Day meals and other schemes in the last four years; and
- b) if so, the State-wise and the scheme-wise details thereof and the reasons thereof?

- (a) & (b): The funds for implementation of various Centrally Sponsored Schemes (CSS) are generally released to the State governments in advance on the basis of proposals received from the States. Subsequent releases to the State governments are subject to receipt of proposals from the states, submission of utilization certificate of funds released earlier, and compliance by the States to scheme guidelines, and other stipulated conditions. The details of funds released under various Centrally Sponsored Schemes to the States for the last four years are attached as Annexure. Further, under the Expenditure Profile 2025-2026 (of the Union Budget 2025-26) in Statement 4AA, the Union Government has disclosed the fund balances under Single Nodal Agency (SNA) Accounts with States/eligible UT Governments in respect of select Centrally Sponsored Schemes.
