FUND ALLOCATION FOR AMBULANCES UNDER NHM

296. SHRI SANJEEV ARORA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the allocation of funds for ambulances under NHM in the last three years, State-wise;
- (b) the number of ambulances under dial 108, dial 102, dial 104 and other patient transport vehicles under NRHM, State-wise;
- (c) whether Government is planning to integrate ambulance numbers; and
- (d) if so, the details thereof?

ANSWER

**THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE
(SHRI PRATAPRAO JADHAV)**

(a) to (d) The Ministry of Health & Family Welfare provides technical and financial support to States/UTs for strengthening the National Ambulance Services across the nation. “Public Health and Hospitals” is State subject, the primary responsibility of strengthening public healthcare system, including efforts to have required number of ambulances ensuring their functionality and operationality lies with the respective State/UT Governments.

Under National Health Mission MIS, data is collected as per type of ambulance (Advanced Life Support/Basic Life Support/PTV/Bike/Boat/Others). State/UT-wise number of Basic Life Support (BLS) and Advanced Life Support (ALS) ambulances available and operational under NHM as on 30th June, 2024 is attached at **Annexure-A**.

National Highways Authority of India (NHAI) has Emergency helpline number 1033 on National Highways (including National Expressways) under their jurisdiction. Terms of MoU with Centre for Development of Advanced Computing (C-DAC) and Indian Highways Management Company Limited (IHMCL) for development of Dashboard and App for integration of 1033 with 108 and 112 have been finalized.

State-wise allocation of funds for ambulances under NHM in the last three years is enclosed at **Annexure-B**.
