**BED AND BREAKFAST SCHEME**

1104 SHRI HARSH MAHAJAN:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government considers its Bed and Breakfast (B&B) scheme as a success;
- (b) if so, the details thereof;
- (c) if not, the main reasons behind the failure of the scheme;
- (d) the number of people who have applied for the registration for the B&B scheme in Himachal Pradesh during the last three years, year-wise and district-wise;
- (e) the number of people whose online applications for B&B Registration are pending in Himachal Pradesh, in the last three years, the reasons thereof; and
- (f) the steps taken by Government to advertise this scheme world-wide?

**ANSWER**

THE MINISTER OF TOURISM

(a) to (c): Yes. The Ministry of Tourism under its voluntary scheme of Classification classifies accommodation units, including Bed and Breakfast (B&B). As on date, the number of B&Bs classified by the Ministry of Tourism is 515.

(d): The year-wise and district-wise data of units from the State of Himachal Pradesh for the past three years (2022, 2023, 2024) that have applied for registration for B&B is as follows:
