WOMEN PARTICIPATION IN MSMEs AND BANKERS CO-OPERATION

68. SHRI MASTHAN RAO YADAV BEEDHA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) women entrepreneurs under various schemes of Ministry in Andhra Pradesh, and their percent, year-wise over last three years, district-wise, scheme-wise especially in SPS Nellore District.
- (b) the details of measures taken by Government to enhance female participation in MSMEs in Andhra Pradesh;
- (c) the details of funds allocated, utilized for women MSMEs in AP over last three years, district-wise
- (d) whether Government is aware that the bankers have not been cooperating with new women OBCs, SCs and STs entrepreneurs who are starting MSMEs; and
- (e) if so, measures taken by government to improve OBC, SC and ST women in MSMEs?

(a) to (e): A statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (e) OF THE RAJYA SABHA STARRED QUESTION NO. 68 FOR ANSWER ON 10.02.2025.

(a): The data on women entrepreneurs under various schemes of Ministry in Andhra Pradesh, and their percent, year-wise over last three years, district-wise, scheme-wise especially in SPS Nellore District is given in Annexure I.

(b): Government has taken a number of initiatives to increase the participation of women in MSMEs in the country including Andhra Pradesh, such as:

- i. To benefit women entrepreneurs, the Public Procurement Policy was amended in 2018 mandating Central Ministries/Departments/Undertaking to procure at least 3% of their annual procurement from micro and small women entrepreneurs. It has been seen that procurement from women MSEs during 2021-22 was Rs.1713.27 cr., which has increased to Rs.3271.59 cr., as on 6/2/2025.
- ii. Udyam Registration Portal was launched on 01.07.2020 which is fully online, paperless and based on self-declaration. Those with PAN details can register on Udyam and become eligible for Priority Sector Lending (PSL) and to avail of benefits of schemes of the Ministry of Micro, Small and Medium Enterprises. For those informal enterprises which do not have PAN and are exempted from GST, Udyam Assist Platform (UAP) was launched on 11th January 2023. More than 41% registered on Udyam/Udyam Assist Portals are owned by women. Special drives for registration of women owned MSMEs under Udyam Registration / Udyam Assist Portals are undertaken
- iii. To support women entrepreneurs under Credit Guarantee Scheme for Micro and Small Enterprises, the following two provisions have been introduced for micro and small women entrepreneurs w.e.f. 01.12.2022:
 - (i) Guarantee coverage of up to 85%, as against the 75% for others; and
 - (ii) 10% concession in annual Guarantee fees
- iv. Prime Minister's Employment Generation Programme (PMEGP) is a credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and rural/urban unemployed youth. Out of the total PMEGP beneficiaries, 39% are women and they are provided higher subsidy (35%) vis-a-vis non-special category (upto 25%).
- v. Participation of women entrepreneurs in trade fairs under Procurement and Marketing Support Scheme is subsidized to the extent of 100% vis-a-vis 80% for other entrepreneurs.
- vi. Ministry of MSME launched 'PM Vishwakarma' Scheme on 17.09.2023, to provide a number of benefits to the traditional artisans and craftspeople including women, engaged in 18 trades. The registration of women artisans has been 35.26% of the total registration under the scheme as on 7/2/2025.

(c): The Schemes being implemented by Ministry of MSME are mostly Central Sector Schemes such as Prime Minister's Employment Generation Programme (PMEG), PM Vishwakarma (PMV) Yojana, Technology Centre and Extension Centre (TCECs), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), National SC-ST Hub (NSSH) etc. Hence, the question of allocation of funds to the State / districts does not arise.

(d) and (e): Government has been promoting inclusive growth by introducing various measures and initiatives from time to time. The measures taken by Government *inter alia* to improve OBC, SC, and ST women participation in MSMEs are :-

- (i) **Pradhan Mantri Mudra Yojana (PMMY)** was launched on 08.04.2015 to extend collateral free credit up to Rs.20 lakh by Member Lending Institutions (MLIs), i.e., Scheduled Commercial Banks (SCBs), Non-Banking Financial Companies (NBFCs) and Micro Finance Institutions (MFIs). Any individual, who is otherwise eligible to take a loan and has a business plan for small business enterprise can avail loan under the Scheme for income generating activities in the manufacturing, trading, service sectors including activities allied to agriculture across four loan categories, viz. Shishu (loans upto Rs. 50,000/-), Kishor (loans above Rs. 50,000/- and upto Rs. 5 lakh), Tarun (loans above Rs. 5 lakh and upto Rs. 10 lakh) and Tarun Plus (loans above Rs. 10 lakh and upto Rs. 20 lakh for those entrepreneurs who have availed and successfully repaid previous loans under the 'Tarun' category w.e.f. 24.10.2024).
- (ii) **Stand-Up India (SUI) Scheme** launched on 05.04.2016 has been extended up to the year 2025. The objective of the Scheme is to facilitate loans from Scheduled Commercial Banks (SCBs) of value between Rs. 10 lakh and Rs. 1 crore to at least one Scheduled Caste (SC) or Scheduled Tribe (ST) borrower and one Women borrower per bank branch for setting up greenfield enterprise in manufacturing, services or trading sector including activities allied to agriculture.

The PMMY and SUI Schemes are being implemented across the country. As on 24.01.2025, a total of 51.67 crore loans amounting to Rs.32.61 lakh crore has been extended under PMMY, since inception of the Scheme out of which a total of 34.96crore (68%) loans have been sanctioned to Women Entrepreneurs since inception of the Scheme. Further, the Stand Up India scheme has facilitated over 2.59 lakh loans to SC/ST and Women entrepreneurs across the country and a total of 2.15 lakh (83%) loans have been sanctioned to Women Entrepreneurs since inception of the Scheme as on 27.01.2025.

District-wise details of women beneficiaries in State of Andhra Pradesh over last three years is attached as Annexure II and III.
