- (d) the State that attracted the highest private investment in the current financial year?

- (a):** 1,31,853 domestic companies have been incorporated in the country during the current financial year and the State wise list may be seen on the DPIIT website with following URL:

- (b):** 43 foreign companies have been incorporated in the country during the current financial year and the state wise list is at Annexure I.

- (c):** DPIIT does not maintain any ranking of states/UTs based on Ease of Doing business. However, under Business Reform Action Plan (BRAP), States/UTs are assessed on the basis of implementation of designated reform parameters in the following four percentage-based grades:

- i. TOP ACHIEVERS: which score above 95%
- ii. ACHIEVERS: which score 90% to 95%
- iii. FAST MOVERS: which score 80% to 90%
- iv. ASPIRERS: which score Below 80%

Grading of states/UTs given in 2024 on the basis of BRAP 2022 Survey is at Annexure II.

- (d):** Maharashtra has attracted the highest Foreign Direct Investment in the current financial year.
