**STATUS OF SMART CITY PROJECTS IN UP**

**692. SHRI JAVED ALI KHAN:

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) the status of Smart City projects in the State of Uttar Pradesh along with allocation, release and utilization of funds for the same during the last three years and current year till 31st January 2025, year-wise and smart city-wise;
- (b) the steps taken to address urban housing by Government amidst urbanization programmes; and
- (c) whether Government has introduced schemes or policies to increase urban mobility and public transport reliability under the Smart Cities programme?

**ANSWER**

- (a) Under the Smart Cities Mission (SCM), ten cities, viz. Agra, Aligarh, Bareilly, Jhansi, Kanpur, Lucknow, Moradabad, Prayagraj, Saharanpur and Varanasi have been selected in the State of Uttar Pradesh. As on 20.01.2025, work orders have been issued in 889 projects amounting to ₹21,104 crore, of which 863 projects (i.e. 97% of total projects) amounting to ₹20,371 crore have been completed and the remaining 26 projects amounting to ₹733 crore are under implementation. The city wise details of projects for these 10 cities are at Annexure-I. The city wise, year-wise details of allocation, release and utilization of central share fund during the last three years and current year till 31st January 2025 is at Annexure-II.
- (b) To address urban housing, Ministry of Housing and Urban Affairs (MoHUA) supplements the efforts of the States/ Union Territories by providing central financial assistance under Pradhan Mantri Awas Yojana - Urban (PMAY-U) since June 25, 2015 with the aim of providing all-weather pucca houses equipped with basic amenities to all eligible urban beneficiaries. The scheme operates through four verticals- Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR), and the Credit Linked Subsidy Scheme (CLSS), as per the eligibility criteria outlined in the scheme guidelines. Mission Period was up to 31.03.2022 which has been extended up to 31.12.2024 only to complete all the sanctioned houses without changing funding pattern and implementation methodology of the scheme. CLSS vertical has not been extended beyond 31.03.2022.

- (c) Government of India's policy and strategy for Indian Urban Development follows the provisions as laid down in the Constitution of India. It is pertinent to mention here that 'Land' and 'Colonization' are State subjects. Further, as per the 12th Schedule of Indian Constitution (Article 243W), Urban Planning including Town Planning is the responsibility of Urban Local Bodies (ULBs)/ Urban Development Authorities.

Government of India supplements the efforts of the State/UT Governments through schematic interventions/ advisories and formulating policies, viz., National Urban Transport Policy, 2006, Metro Rail Policy, 2017 and Transit Oriented Development Policy, 2017, in order to plan and implement the urban transport systems in most sustainable and viable manner.

Under Smart Cities Mission, 1,579 projects amounting to ₹ 37,304 crore (90% of the total projects outlay) have been completed in urban mobility sector. These projects range from smart roads, multilevel car parking, promotion of pedestrian pathways, cycle tracks, Intelligent Traffic Management System etc.
