PENDING APPLICATIONS UNDER THE UJJWALA SCHEME

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state: -

- (a) the total number of applications pending under the Pradhan Mantri Ujjwala Yojana (PMUY) across the country, State- wise;
- (b) the number of pending applications from the state of Odisha, district –wise details thereof;
- (c) the timeline set for clearance of pending applications, State-wise;
- (d) whether subsidies are provided on refilling cylinders to PMUY beneficiaries, and if so, details thereof; and
- (e) the total number of beneficiaries under the PMUY, particularly in the State of Odisha, district-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS

(SHRI SURESH GOPI)

(a) to (e): Pradhan Mantri Ujjwala Yojana (PMUY) was launched on 01.05.2016 to release deposit free LPG connection to adult women from poor households across the country. The target to release 8 crore connections was achieved in September, 2019. To cover the remaining poor households, Ujjwala 2.0 was launched in August 2021 and till January 2023, 1.60 crore Ujjwala 2.0 connections had been released. Further, in view of fresh requests, in September 2023, Government approved release of additional 75 lakh PMUY connections. OMCs have completed the release of these 75 lac PMUY connections as of 8th July 2024.

As on 01.01.2025, there are 10.33 crore PMUY connections across the country, including 55.50 lakh connections in the State of Odisha. As on 01.01.2025, there were 29.02 lakh pending applications in the country including 39,192 in State of Odisha for release of connections under the said scheme. No timeline has been set for clearance of pending application under PMUY.

To make LPG more affordable to PMUY consumers and ensure sustained usage of LPG by them, Government started a targeted subsidy of Rs.200/- per 14.2 kg cylinder for up to 12 refills per annum (and proportionately pro-rated for 5 Kg connections) to the PMUY consumers in May 2022. In October 2023, Government increased the targeted subsidy to Rs.300 per 14.2 kg cylinder for up to 12 refills per annum (and proportionately pro-rated for 5 Kg connections). After a targeted subsidy of Rs. 300/cylinder to PMUY consumers, Government of India is providing 14.2 Kg LPG cylinders at an effective price of Rs.503 per cylinder (in Delhi). This is available to more than 10.33 crore Ujjwala beneficiaries, across the country.
