Will the Minister of Ayush be pleased to state:

- (a) the steps taken to include emerging Ayurveda practitioners and researchers under National Dhanwantari Ayurveda Award;
- (b) the measures being taken to strengthen the infrastructure of Ayurveda research, education and clinical practice in rural and urban areas;
- (c) whether the Government is planning to launch a ‘Mentorship Programme’ wherein former winners would guide young Ayurveda practitioners and researchers; and
- (d) if so, details thereof?

ANSWER

**THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH
(SHRI PRATAPRAO JADHAV)**

- (a) The National Dhanwantari Ayurveda Award is conferred on notable Ayurvedic practitioners/researchers who have done commendable service to society and having higher achievements in the field of Ayurveda. Ayurveda Day, being celebrated every year on the day of Dhanwantri Jayanti (Dhanteras) was notified by the Ministry of Ayush vide gazette notification dated 01.06.2017. The day is celebrated through undertaking various activities throughout the country for promotion, propagation and popularization of Ayurveda.

The revised resolution in this regard was published in the Gazette of India, Extraordinary Part –I on 7th November, 2023.

Since 2023, the nominations for the Dhanwantari awards are invited through the common unified National Awards Portal – Rashtriya Puraskar portal of Ministry of Home Affairs (MHA). - (b) Public Health being a State subject, strengthen the infrastructure in the country comes under the purview of respective State/UT Governments. However, under Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of financial assistance for setting up of Ayush Educational institution in the States where availability of Ayush teaching institutions is inadequate in Government. Accordingly, State/UT Governments may avail eligible financial assistance by submitting the suitable proposals through State Annual Action Plans (SAAPs) as per the provision of NAM guidelines.

Further, Ministry of Ayush, Government of India, has set up Central Council for Research in Ayurvedic Sciences (CCRAS), an autonomous organization for undertaking, coordinating, formulating, developing, and promoting research on scientific lines in Ayurvedic sciences. The activities of the Council are carried out through 30 peripheral Institutes in 25 States of the Country out of which health care services through OPD/IPD is being provided at 26 Peripheral Institute/ Centres. The list is annexed at **Annexure-I**.

Furthermore, the following National Institutes of Ayurveda under the Ministry are imparting quality Medical Education, conducting Research and providing Ayurveda treatment through its attached Hospital across the country:-

- i. National Institute of Ayurveda (NIA), Jaipur and its extension centre at Panchkula.
- ii. All India Institute of Ayurveda (AIIA), New Delhi and its satellite centre at Goa.
- iii. Institute of Teaching and Research in Ayurveda (ITRA), Jamnagar, Gujarat
- iv. Rashtriya Ayurveda Vidyapeeth (RAV), New Delhi.
- v. North Eastern Institute of Ayurveda and Homeopathy (NEIAH), Shillong, Meghalaya.
- vi. North Eastern Institute of Ayurveda & Folk Medicine Research (NEIAFMR), Pasighat, Arunachal Pradesh.

- (c)&(d) No such proposal is under consideration to launch a ‘Mentorship Programme’ wherein former winners would guide young Ayurveda practitioners and researchers. However, the steps taken by the National Commission for Indian System of Medicine, New Delhi (NCISM) to promote Research in Ayurveda sector are as follows:-

I. Publication Grant:-

NCISM is giving publication grant to the teachers, UG and PG scholars, and practitioners of Ayurveda Medical system for publication of Research papers in quality journals as per the guidelines.

II. Studentship Program for Ayurveda Research Ken (SPARK)

NCISM in collaboration with Central Council for Research in Ayurvedic Sciences (CCRAS) under (SPARK) for undergraduate students of Ayurveda colleges were launched.

III. PG-STAR:-

NCISM in the collaboration with CCRAS has launched Scheme for Training in Ayurveda Research for Post Graduate scholars (PG-STAR).

IV. LITERARY RESEARCH:-

CCRAS is giving grant for literary research to the individuals and also working in collaboration with the teaching institutions for research purpose
