**LINKING OF PM-KISAN PAYOUT TO INFLATION AND PRICE RISE**

2417. SHRI YERRAM VENKATA SUBBA REDDY:

Will the Minister of Agriculture and Farmers Welfare be pleased to state:

- (a) whether Government has released 19th installment of Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) recently;
- (b) the details of beneficiaries in the 19th installment, State-wise;
- (c) the details of beneficiaries under PM-KISAN since 2020, installment-wise, State-wise;
- (d) the amount spent under PM-KISAN till date, State-wise;
- (e) whether there are any plans to link PM-KISAN payout to inflation and price rise; and
- (f) if not, the reasons therefor?

**ANSWER**

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE  
(SHRI RAMNATH THAKUR)

(a) to (d): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of cultivable land-holding farmers. Under the scheme, a financial benefit of Rs 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode.

A farmer-centric digital infrastructure has ensured the benefits of the scheme reach all the farmers across the country without involvement of any intermediaries. Maintaining absolute transparency in registering and verifying beneficiaries, the Government of India has disbursed over Rs 3.68 lakh Cr. in 19 installments since inception. 19th Installment of PM-Kisan scheme was released on 24th February, 2025 and more than 9.8 Crore farmers received the benefits amounting to over Rs. 22,000 Crore.

The State-wise and instalment-wise details of the beneficiaries benefited under PM-KISAN and amount released to them since FY 2020-21 is attached at Annexure.
