## Showing of all DD channels by cable operators

2283. SHRI KA. RA. SUBBIAN: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) the steps taken by the Government to see that cable operators show all the DD channels to the viewers;

(b) whether Government have formulated any code of conduct rules in this regard;

(c) if so, the details thereof; and

(d) if not the reasons therefor?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) to (c) Govt. has amended the Cable Television Networks (Regulation) Act, 1995 through Cable Television Networks (Regulation) Amendment Act, 2000 with a view to, *inter-alia*, making it mandatory for every cable operator to re-transmit at least two Doordarshan terrestrial channels and one regional language channel of a State in prime band. Prasar Bharati vide their Notification S.O. 823(E) dated 13.9.2000 have specified the number and name of Doordarshan channels to be re-transmitted by cable operators in their cable service in different States and the manner of reception and re-transmission of such channels. Action for violation of these provisions is to be taken by the authorized officers i.e. DMs, SDMs, and Commissioners of Police and such other officer as may be notified by the [11 December, 2000]

2284. SHRI C.O. POULOSE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state;

(a) the total number of Television Channels functioning under Governments in various countries, country- wise; and

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) The Government of India does not maintain such information.

(b) With more than 50 channels available in the Country, India is quite well provided in terms of TV channels. It is not lagging behind.
