

### Conditions for concession to Senior Citizens

\*120 SHRIMATI KAMLA MANHAR: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether Government have decided to further relax the conditions for giving concessions on air fares to senior citizens and students in the domestic sectors on Air India, Indian Airlines and Alliance air;

(b) if so, the details thereof including the age prescribed for being a senior citizen; and

(c) what are the concessions available under various categories including Apex and Super-Apex fares on these airlines and the reasons for not providing these fares on Delhi-Srinagar and Delhi-Bhubaneswar sector?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI RAJIV PRATAP RUDY): (a) and (b) Indian Airlines offers a number of discounts/concessions to various categories of travelling public based on social obligations. The annual impact of these discounts was estimated at Rs. 64.14 crores. Keeping in view the severe financial constraints of Indian Airlines, the entire issue of withdrawal/continuation of these concessions or providing subsidy to Indian Airlines on this account was reviewed by the Government. It was, *inter alia*, decided to continue the Senior Citizen concession and student concession with the following modifications:-

#### Senior Citizen Concession:

Conditions before modifications	Conditions after modifications
Concession for both Indian and Foreign Nationals	Concession for Indian national residing in India
All types of journeys by Economy Class	For Round trip and circle trip travel only
No minimum stay requirement	Minimum stay for seven days at destination
Re-routing permitted	Re-routing not to be permitted
No time limit for purchase of ticket	Confirmed ticket to be purchased at least seven days prior to departure

### Student Concession:

Conditions before modifications	Conditions after modifications
For travel on any domestic sectors	For travel between Home town and place of study only

The aforesaid modifications in the Senior Citizens Concessions and Student Concessions were implemented, w.e.f. 7th July, 2003.

On receipt of a large number of representations, the aforesaid conditions were further reviewed and the following conditions governing Senior Citizens discount and Student Concessions were relaxed w.e.f. 1st October, 2003:

* Minimum seven days stay at destination in case of Round Trip journey and seven days stay at each intermediate point in case of Circle Trip journeys.	* Minimum seven days stay reduced to minimum two nights stay at destination in case of Round Trip journey and at each intermediate point in case of Circle Trip journey.
Student Concession	
* Part travel upto Kolkata not permitted for Students travelling on Student Concession on flights operating between points in North East and Kolkata.	* Students permitted to travel on flights operating between points in North East and Kolkata when the sectors form a part of journey permitted i.e. from place of study to Home Town.

The eligibility criteria for availing of the senior citizen discount is 65 years in case of male senior citizen and 63 years in case of female on the date of commencement of journey.

(c) **Air India** offers a special discount of 55% of the basic fare on its domestic routes to senior citizens, cancer patients, armed forces personnel and blind persons. Air India does not offer Apex and Super-Apex fares on the domestic sectors.

#### Indian Airlines/Alliance Air

The details of concessions extended by Indian Airlines/Alliance Air are given in the Statement (See below).

However, the Smart APEX Fares (D-7 and D-21) presently offered by Indian Airlines are special fares which are much lower than the Normal sector fares. These fares are offered on specified domestic sectors for travel in Economy Class depending upon certain factors like extent of competition, market size, capacity offered, the potential to generate new traffic by diversion of existing traffic from other modes of transport etc. The scheme is offered for specified period of time on specified sectors. Fares have not been introduced, in view of these factors, on Delhi-Srinagar and Delhi-Bhubaneshwar sectors.

### **Statement**

#### *Special Fares—Domestic (On Permanent Basis)*

- \* All Discount unless and until specified otherwise, shall be applicable on Indian Airlines Domestic Network on Economy Class INR Sector Fares only for travel by Economy Class.
- \* All Discounts are applicable on the fare Component of INR Fares.
- \* In case of INR Fares, IATT and PSF are charged full unless and until specified otherwise.
- \* Special Fares-Domestic-applicable to Indians and Foreigners residing in India unless specified otherwise.
- \* No Special Fares/Discounts are available on Rights operated by a Dornier aircraft.
