## **DDA's residential schemes**

- \*191. SHRI G.K. VASAN: Will the Minister of URBAN DEVELOPMENT AND POVERTY ALLEVIATION be pleased to state:
  - (a) the number of DDA's residential schemes for flats and plots;
- (b) the number of people on waiting list, scheme-wise and category-wise;
- (c) the criteria for allotment to the waitlisted people scheme-wise and category-wise;

- (d) whether out of turn allotments are being made if so, on what basis and to whom; and
- (e) the details of the new schemes launched, if any, for economically weaker sections?

THE MINISTER OF STATE OF THE MINISTRY OF URBAN DEVELOPMENT AND POVERTY ALLEVIATION (SHRI BANDARU DATTATRAYA): (a) DDA has reported that since inception, it has launched 36 residential schemes for allotment of flats and one residential scheme for allotment of plots.

(b) The number of people on waiting list at present, scheme-wise and category-wise under different schemes is as under:

- (c) All waitlisted registrants in each category in different schemes have been allotted priority numbers by DDA. As and when vacant flats/plots become available, allotment to an equivalent number of waitlisted registrants is made as per their seniority in the priority list, through a computerised draw.
- (d) Out of turn allotment of DDA flats is made only to the widows of Government servants who died in harness and of those who were killed by terrorists and where the family needs to stay in Delhi due to reasons of employment/education etc. This is subject to the further condition that not more than 1% DDA flats in Janta, LIG and MIG category would be earmarked for allotment under this category during each year.
- (e) No new scheme has been launched at present by DDA for economically weaker sections.
