However, the Ministry of Tribal Affairs releases funds to the State Governments having Tribal Sub Plan under Special Central Assistance (SCA) to Tribal Sub Plan (TSP). SCA is an additive to the State Plan efforts of tribal development for filling the critical gaps in the family-based employment-cum-income-generation activities and also those activities run by the Self Help Groups (SHGs)/Communities in the Tribal Sub Plan areas, and the infrastructure incidental thereto.

(b) to (d) A statement showing State-wise details of funds released and utilized by the State Government under Special Central Assistance to Tribal Sub Plan during the last three years is enclosed (See below). This indicates the progress of expenditure.
