THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI ANNASAHEB M.K. PATIL): (a) and (b) Desertification is a land degradation process due to extreme climatic conditions, inappropriate management practices and socio-economic conditions, Studies conducted by Department of Space indicate the process of desertification in pockets of some States including Gujarat.

- (c) A High Level Technical Committee in 1994-95, identified 55,424 square kilometers as arid area coverage in Gujarat for control of desertification under Desert Development Programme.
- (d) According to Wastelands Atlas of India prepared by National Remote Sensing Agency Department of Space, the total extent of Saline area in Gujarat is 7637.34 square kilometers that also comprises coastal areas with ingress/inundation of seawater.

Powers to plan, sanction, implement and execute individual rural drinking water supply schemes vest with State Governments. The
