THE MINISTER OF STATE OF THE MINISTRY OF CIVILAVIATION (SHRI RAJIV PRATAP RUDI): (a) and (b) In order to improve air connectivity in North East Region Alliance Air has introduced ATR-42 services *w.e.f.* December, 2002. This has increased the available of seats from 7518 to 8932 per week and the number of flights from 74 to "< 29 per week.

(c) and (d) There is a proposal from the Government of Nagaland for construction of a new airport at Chiethu near Kohima. Airports Authority of India has carried out a preliminary feasibility study in this regard.

## **Ahmedabad-New York Direct Flight**

†2178. SHRI JAYANTILAL BAROT: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) Whether Government propose to operate a direct flight of Air India to New York (without changing plane) from Ahmedabad; and
- (b) the number of passengers who travel through the flights of Air India ard Indian Airlines every month and the number thereof during the three years?

THE MINISTER OF STATE OF THE MINISTRY OF CIVILAVIATION (SHRI RAJIV PRATAP RUDI): (a) In the current schedule, Air India has extended six flights on the New Jersey/Paris/Mumbai sector and one service on the Chicago/London/Mumbai sector to Ahmedabad with no change of plane and the passengers booked to travel on these flights need not change plane at any of the transit points and can travel right through to Ahmedabad. However, for travel out of Ahmedabad, change of plane is required at Mumbai.

(b) The number of passengers carried by Air India and Indian Airlines (including Alliance Air) during the last three years are as under:
