## Scam in the purchase of wireless sets for warning of floods

†\*32l. PROF. RAMDEO BHANDARY: Will the Minister of WATER RESOURCES be pleased to state:

- (a) the details of actual requirement of wireless sets for forecasting and warning of floods in rivers flowing through India and Nepal alongwith the number of wireless sets purchased and the amount spent on each such set including the year of purchase and other information;
- (b) the names of places where these sets have been installed and the condition of these sets at present;
  - (c) whether these sets have been utilised, if so, the details thereof during last three years;
  - (d) the action taken so far on the written complaints by a Member of Parliament to investigate the scam regarding purchase of these sets; and
    - (e) the steps being taken by Government in this regard?

Against the requirement of 86 wireless sets a total of 51 wireless sets were purchased during March 1989 to March 1991. Out of these sets, 48 sets have become unserviceable due to non availability of spares as the PSU which supplied these sets had closed down. Subsequently 45 more wireless sets were purchased during the period June 1995 to December 1997.

The details of cost along with year of purchase, type/make of equipment have been given in the Statement- I. (See below)

The names of places where the wireless sets have been installed along with their condition are given in Statement-II. (See below)

The wireless sets have been utilized for receiving the rainfall data and river gauge data from Nepal during the monsoon period. The number of stations from which rainfall data and river gauge data have been received during past three years is as under:
