- (c) The vacanices in the rank of Asstt Comdt (Direct Entry) and Sub-Inspector (Direct Entry) are projected to the UPSC & SSC respectively and filled up on an annual basis. Other direct entry posts are filled up by the Force as per prescribed procedure. The promotional posts in various streams are filled up as per instructions of the Government.
- (d) Nil. However, 04 Ex-Army Officers were serving in the rank of DIG on re-employment basis as on 1st April, 2003
- (e) There is provisions in Recruitment Rules to fill up 10% of posts of DIG be deputation or re-employment of Army Officers of the rank of Brigadier. Serving Army Officers on deputation to BSF on retirement from Army are deemed to be on reemployment till they attain the age of suprannuation.
