Production of salt from Sambhar Lake

77. SHRI AIMADUDDIN AHMED KHAN (DURRU): Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

(a) the production of salt from the Sambhar Lake water in Rajasthan during the last three years, year-wise;

(b) the percentage and actual fall in the production of salt from the Sambhar Lake water during the year 2001-02 and as on the date;

(c) the reasons for the shortfall; and

(d) the steps contemplated by Government to improve the situation?

THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI SUBODH MOHITE): (a) Sambhar Salts Ltd. (SSL), produces salt from Sambhar Lake water and sub-soil brine from lake bed. The production of SSL for last three years from both sources is an under:-

(Production in lakhs MT)

2000-01	2001-02	2002-03

(b) Production of salt during 2001-02 was higher as compared to the previous year, but fell by 15% in 2002-03.

(c) The reasons for short fall in 2002-03, *inter-alia* include successive drought condition and obstruction in free-flow of water into the lake from catchment area due to construction of anicuts and dams on rivulets, tributaries and rivers leading to the Sambhar Lake and development of private salt manufacturing on the outskirts of lake boundaries.
