

**BIDS for Metro Airports**

156. MISS MABEL REBELLO: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) what are the details of the airports proposed to be privatized;
- (b) whether Foreign Airlines, such as Qatar Air, has been permitted to bid for Metro Airports in our country;
- (c) if so, the names of other airlines which are permitted; and
- (d) whether this will infringe upon our security system?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI RAJIV PRATAP RUDI): (a) The airports at Delhi, Mumbai, Chennai and Kolkata have been under consideration for restructuring through private sector participation.

(b) and (c) No bids have been invited so far.

(d) In order to ensure that there is no infringement of security systems due to restructuring of airports, it has been decided that the statutory functions like Air Traffic Control and Security will continue to be provided by Airports Authority of India. The other sovereign functions like immigration, customs etc. shall be provided by the designated Government agencies.

**Modernisation of Delhi and Mumbai Airports**

157. SHRIMATI BIMBA RAIKAR: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether it has been estimated that modernisation of Mumbai and Delhi airports would require an investment of Rs. 1864 crores and Rs. 2030 crores, respectively;

(b) whether Government have apprehensions over the private sector investing in such projects because of negative returns;

(c) whether the Airports Authority of India is keen to secure a Government grant as it needs compensation for losses when the principal earning assets in Mumbai and Delhi are hived off; and

(d) if so, what is Government's reaction thereto?

(SHRI RAJIV PRATAP RUDI): (a) and (b) A three-member Committee has been constituted to examine the issue of route rationalisation between Air India and Indian Airlines for their common international operations taking into account their views and keeping in view the short term/long term interests of the two airlines etc.
