### **Setting up of Utkal Chapter in Orissa**

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that Utkal Chapter, branch of National Human Resource Development has been set up in Orissa, if so, the main objective and other details thereof;

(b) the number of existing chapters operating under National Human Resource Development network; and

(c) how far this would help in the development of the State and its people?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) No, Sir. The Ministry of Human Resource

Development do not have any scheme named as National Human Resource Development Network and the question of setting up any chapter/branch thereof does not arise.

MS. PRAMILA BOHIDAR: Sir, I want to know from the hon. Minister whether there is any other similar programme in order to help the State to catch up with the developed States in human-resource sector.

DR. MURLI MANOHAR JOSHI: Sir, the entire education programme is directed towards the development of human resource in all the States, and, Orissa also gets its due. Therefore, there is no need to have any other special programme.

SHRI B.J. PANDA: Thank you, Sir. Sir, the hon. Minister has already clarified that there is no scheme, particularly under this name which has been reported in some regional newspapers for the purpose of monitoring large number of institutes in the private sector, both in technical and management fields. Sir, my question to the hon. Minister — obviously those reports were erroneous — is this: Is it a fact that there are a large number of such private institutes and many of them are unrecognised, as a result of many students get pleased by it? I would like to know from the hon. Minister what are the measures taken to supervise such institutes and to alert the public about them?
