No officer in this Ministry is working on the same post for the last 15 years.

- (d) to (f) Ministry of Non-Conventional Energy Sources is a Scientific Ministry and transfers are decided keeping in view the background and specialization of the various scientists and engineers in the Ministry. Transfer of officials is reviewed by the Ministry from time to time depending upon specific work requirements and introduction of new programmes/schemes.

THE MINISTER OF STATE OF THE MINISTRY OF NON-CONVENTIONAL ENERGY SOURCES (SHRI M. KANNAPPAN): (a) and (b) The Ministry of Non-Conventional Energy (MNES) has received applications from NGOs namely India-Tech Foundation Mumbal, Global

Foundation Mumbai, Wisitex Foundation, New Delhi etc. for participation of MNES by puting non-conventional energy pavilions in the trade fairs/events/exhibitions organized by the, MNES has provided financial support to concerned State Nodal Agencies (SNAs) for their participation in such trade fairs/events/exhibitions organized by the NGOs so that all displays and information could be provided to the visitors in regional languages.

- (c) MNES invites proposals from all the SNAs every year and provide financial support for organizing such awareness campaigns/ exhibition in their States. Besides 25 States have also procured Mobile Exhibition Vans equipped with the working models of non-conventional energy products/devices with the financial support provided by MNES.
- (d) and (e) About 30 exhibitions on non-conventional energy have, so far, been organized since last year by different SNAs for which the Ministry has provided a financial support of about Rs. 32 lakh.
