## Rejection of Delhi Declaration at the climate change meet by the EU

1618. SHRI PARMESHWAR KUMAR AGARWALLA: Will the Minister of POWER be pleased to state:

- (a) whether it is a fact that European Union has rejected the draft of the Delhi Declaration circulated by the Indian Government at the climate change meet;
  - (b) if so, what are the details of the draft circulated; and
- (c) what are the reasons given by the European Union for rejecting it?

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI JAYAWANTI MEHTA): (a) to (c) The European Union did not reject the draft of the Delhi Declaration. A group of developed countries, including the European Union wanted to initiate a process for beginning a dialogue on broader participation of countries in greenhouse gas mitigation commitments for period beyond 2012. This was resisted successfully by the developing countries, including India, on the grounds that the per capita greenhouse gas emissions of the developing countries, in general, were low in comparison to the developed countries, and that the overriding priority for the developing countries was poverty eradication for which economic growth was essential. The Delhi Ministerial Declaration on Climate Change and Sustainable Development was adopted by all Parties as a consensus document.

## Funds Released by PFC

THE MINISTER OF STATE IN THE MINISTRY OF POWER (SHRIMATI JAYAWANTI MEHTA): (a) Power Finance Corporation (PFC) has increased its operation and funds release to various power projects over last few years. Sanctions and disbursements by it during the last five years is as under:

- (b) to (d) An amount of Rs. 3423.56 crores as per details given in Statement has been released upto 18.11.2002 by the Power Finance Corporation during the current financial year 2002-03 (See below). PFC has sufficient financial strength to meet additional requirements for funding bankable power projects in the country. Funds are released by PFC to only such projects which are economically viable and fulfil all the eligibility criteria for funding such projects.
- (e) PFC in addition to the existing instrument of financing, has introduced several new instruments of financing by which entities in the power sector can look forward to improve their capacity and to modernize existing plants and other technological development. PFC is also giving grants for carrying out various types of studies to the power utilities. PFC is giving preference to reforms linked financing programme.
