(b) to (e) The concerned firm has been investigated for violating domestic export control regulations including the Customs Act 1962 and the Foreign Trade (Development & Regulation) Act 1992. After due investigation, the importer-exporter code number of the firm was suspended on August 22, 2002 for violation of provisions of the EXIM Policy 1997-2002. Based on these investigations, courts have taken cognisance in certain cases, wh.ich are pending final disposal.

Missing Indians in UAE

1706. SHRI S.M. LAL JAN BASHA: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have recently received representations on missing persons working in United Arab Emirates;
 - (b) if so, the details thereof;
 - (c) the reasons for delay in finding such persons;
- (d) whether it is a fact that Indian Embassy is slow in activating itself to search and locate the missing persons; and
- (e) what steps Government are taking to expedite enquiries and action on missing persons, particularly Indian women workers?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DIGV'IJAY SINGH): (a) Yes.

- (b) During the current year, eight complaints were received by our Embassy in Abu Dhabi, of which four cases have been solved. In the remaining four cases a response is pending from the U.A.E. Foreign Office/sponsors, Our Consulate in Dubai received four such complaints. These complaints have been referred to the local authorities. The responses are awaited.
- (c) The delay is mainly due to the lack of complete details (particularly addresses etc.) of the missing persons. In some cases, the missing persoris deliberately change their personal particulars or, remain incommunicado for personal reasons.
 - (d) No. Prompt action is taken in respect of each such complaint.

(e) In case the address, telephone number, details of sponsor etc. are known, action Is initiated to make enquiries directly. Otherwise, a request is made to the Ministry of Foreign Affairs, Government of the United Arab Emirates for their assistance. The same procedure is followed in case of women workers.
