### India's share in international IT market

- (a) whether despite swift development of the Indian information technology industry the country's share in international industrial market is only 1.6 per cent and the country depends mainly on North-American market where 67 per cent of software is exported from India; and
- (b) if so, the details of the measures taken/proposed to be taken by Government to increase the export of Indian Software to the fast growing markets of Germany, Japan, France and other countries in order to reduce dependence on North-American market?

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI PRAMOD MAHAJAN): (a) The Indian IT industry has share of about 1.8 per cent of the global market during 2001 -2002 in export of computer software and services.

The export increased from Rs. 28350 crores in 2000-01 to Rs. 36500 crores in 2001-02.

North America continues to be the major export destination for export of Indian computer software and services. However, there has been gradual increase in export to other countries of Europe, Latin America and Asian Region including Japan. Details of the export destinations in 2001-02 are as follows:

■ America : 63%
■ Europe : 26%
■ Japan : 4%
■ Rest of World (RoW) : 7%

- (b) Government has taken following steps to promote export of computer software and services to destinations other than North America:
  - (i) Awareness programs and focussed Road Shows In collaboration with the Industry, organized periodically in potential markets such as EU, Japan, Latin America etc,
  - (li) Financial support to industry for organizing and participating in international fairs, exhibitions & conferences for marketing Indian strength in the sector.
  - (ill) Bilateral cooperation 'rengthened with countries of Europe, Latin America, Japan, Australia and Asian region by entering into Memorandum of Understandings {MoUs}. These MoUs have been used to provide platform for the industry to establish contacts with counterparts in these countries and to explore and increase possibilities of exports.
