- (d) Yes, Sir.
- (e) So far 17 tele-films, 3 tele-plays, 13 documentaries and 3 discussions have been telecast on Doordarshan as part of the campaign against terrorism and insurgency. Also, the surrender of a large number of ULFA activists on 14.08.2000, and an interview with the leader of the surrendered group was telecast. TV reports on peace rallies and programmes on the subject produced by the State Government have also been telecast.
- (f) Prasar Bharati will be telecasting similar programmes on a regular basis in future.

## Programmes Telecast on National and Regional Channels of DD

## ·Proposals Pending for Setting up of AIR and DD Centres

- 3082. SHRI CHO S. RAMASWAMY: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) the details of proposals which have been pending, at present, for setting up of Radio Stations and Doordarshan Centres in different parts of the country, State-wise/Location-wise/District-wise;

- (b) since when; and
- (c) the steps taken to expedite the implementation of such projects in the country?

THE MINISTER OF INFORMATION AND BROAD-CASTING (SHRIMATI SUSHMA SWARAJ): (a) and (b) Requests for setting up of new AIR/Doordarshan Stations are received from time to time by Prasar Bharati and these are taken into consideration while formulating Five Year Plans/Annual Plans, subject to availability of resources and infrastructural facilities.

Prasar Bharati formulates plans for expansion of AIR/Doordarshan facilities in the country after taking into account existing coverage, financial resources, availability of infrastructural facilities at a given place and extent of resultant coverage etc. Prasar Bharati has no list of pending proposals for setting up of Radio Stations or Doordarshan Kendras.

(c) Regular monitoring of all projects in AIR and Doordarshan Network is carried out by Prasar Bharati at Field, Zonal and Head Quarter level and remedical measures, to the extent feasible, are taken for completion of projects within their specified target dates.
