For post exposure prophylxis among health workers in Public Sector hospitals, antiretroviral drugs are being supplied through State AIDS Control Societies. Government has also waived excise duty on antiretroviral drugs to make them affordable to HIV/AIDS patients.

Health Melas

1832. SHRI S.M. LAL JAN BASHA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government have conducted Health Melas in different parts of the country;
- (b) the details of such Health Melas conducted and the years when they were conducted;
 - (c) whether it is a fact that they have been discontinued; and
- (d) in what manner Government propose to reach a large number of people without basic health care?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI A. RAJA): (a) Yes, Sir.

- (b) During the year 2000-01 and 2001-02 Government of India has supported organization of Health Melas at 33 places, as per details given in the enclosed Statement (See below).
 - (c) No, Sir.
- (d) Primary Health services are accessible to nearly 85% people in rural areas through a network of 1,37,311 sub-centres, 22,842 PHCs and 3,043 CHCs, of which 21,429 sub-centres, 3540 PHCs and 588 CHCs are in Tribal areas. Under the Govt. of India norms, each Sub-Centre, PHC and CHC caters to a population of 5,000, 30,000 & 1,00,000 respectively in general areas and 3,000, 20,000 & 80,000 population respectively in hilly and desert areas. Government seeks to further increase access to quality health care, especially in underserved areas, through a number of initiatives under the RCH programme such as organizing RCH Camps at regular intervals at PHCs; strengthening immunization services in border districts through Outreach Scheme; provision of referral transport to pregnant women of indigent families; training dais; promoting establishment

of 24-Hours delivery services; engaging additional ANMs and specialists on contractual basis; funding NGOs to service unserved and underserved areas; and organizing Health Melas.
