THE MINISTER OF STATE OF THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS [MAJOR GENERAL (RETD.) B.C. KHANDURI]: (a) Cement concrete road has longer design life of 20-25 years in comparison to bituminous road designed for 10-15 years. The cost of cement concrete road is about 15-20% more than bituminous road.

(b) At the project preparation stage several factors like type of subsoil, traffic, project size, climatic conditions, availability of materials and equipments, relative costs etc. are considered for deciding the option of concrete or bituminous pavement. The most suitable pavement type is then adopted.

- (b) and (c) Presently, there is a ban on declaration of new National Highways due to funds constraint. The Government may, however, consider declaration of very limited lengths of a few State Highways as National Highway during the course of the Tenth Five Year Plan, keeping in view the traffic needs, *inter-se* priority and availability of funds, after the ban is lifted.
- (d) The Central Government is not neglecting these States and provides funds to the State Governments from the Central Road Fund (CRF) for the improvement of State roads. The details of accruals and release of CRF for the Himalayan States are as under:-
