of the violation and to direct States to strike down the provisions in their State Population Policy which violate the principles of NPP 2000. The Department of Family Welfare does not support the disincentives proposed in some State Population Policies as they violate the principle of National Population Policy, 2000. Minister for Health and Family Welfare, has, in his letter dated 2nd August, 2002 to Chief Ministers of all States/UTs emphasized the need for having a common conceptual framework while formulating State Population Policies and Strategies. Ministry of Health & Family Welfare has already constituted a "National Level Resource Committee" vide order dated 8th March, 2002 to provide technical support to State Governments in formulation of State Population Policies in consonance with letter and spirit of the National Population Policy, 2000.
