Terming murder as suicide by Delhi Police

2931. DR. ABRAR AHMED: SHRI SANTOSH BAGRODIA:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government's attention has been drawn to the article "Court summons cops in murder case" appeared in The Hindustan Times on August 10, 2002;
- (b) whether this is a common practice by the Delhi Police to term murder as suicide in their preliminary investigation in order to lessen their work-load:
- (c) if so, the details of such cases in Delhi where such practices have been brought to the notice of Government; and
- (d) the reaction of Government to the above mentioned case and the similar cases reported?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHENNAMANENI VIDYASAGAR RAO): (a) to (c) Yes, Sir. The order passed by the Court of the Learned Metropolitan Magistrate has, however, been challenged before the High Court of Delhi and the matter is sub-judice. There has been no other instance of similar nature brought to the notice of Delhi Police in the recent past.

(d) The police officials are duty bound to conduct investigation in a fair, objective and proper manner and if any lapse is detected, the delinquent police officials are suitably punished.

Road accidents in Delhl

THE MINISTER OF STATE OF THE MINISTRY OF NON-CONVENTIONAL ENERGY SOURCES (SHRI M. KANNAPPAN): (a) and (b) Six renewable energy project proposals from India, all in the private sector, have been short listed under the Certified Emission Reduction Unit Programme Tender (CERUPT) floated by the Government of Netherlands. The details of these projects are given in the Statement enclosed. There is no proposal at present with Government for setting up of renewable energy projects with Dutch assistance.
