## Action Plan to promote indigenous steel production

- † 3102. SHRI ANANATRAY DEVSHANKER DAVE: Will the Minister of STEEL be pleased to state:
- (a) whether any action-plan has been formulated to promote indigenous steel production so as to export it in international market;
- (b) whether private sector participation is being encouraged to achieve the set targets;
  - (c) if so, the details thereof; and
- (d) the difficulties presently being faced by the Indian Steel Industry?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL (SHRI BRAJ KISHORE TRIPATHY): (a) to (c) No, sir. Government has not formulated any Action Plan to promote indigenous production of steel for export purposes. As per the existing policy, exports of iron and steel are freely allowed. Production and exports of iron and steel and their destination depend on several factors such as domestic and international demand, domestic prices, prices in importing countries etc. These factors are usually dynamic and change frequently. Based on the prevailing market conditions, enterprises both in public and private sectors themselves explore and tap the export markets.

  - v) Concessional rate of duty on steel imports for infrastructure projects
  - vi) Anti Dumping duty/Countervailing Duty petitions against Indian Steel by EU, USA and Canada.
