According to the news item, the doctors at a private hospital in Delhi, carried out Endoscopic Vein Harvesting (EVH), a new technique on a diabetic patient while performing the procedure of coronary bypass surgery on him. In the procedure, rather than having a Iprge incision in the leg of the patient, an endoscope is connected to a video camera and inserted through one to three small incisions in the leg allowing the surgeon to remove a vein with minimal stress to the leg. The technique is used is still new and it takes time to get wide-spread acceptance. Further, the procedure has its own advantages & disadvantages. As every surgical patient is unique, it is for the surgical team to recommend the best procedure for a patient.
