(d) Exploratory efforts for hydrocarbons in any area, including Tripura, are targeted both for oil and gas. However, Tripura and the adjoining areas of Bangladesh are gas prone, as proven from exploration results so far.

## Agreement with Iraq in Oil Exploration

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH GANGWAR): (a) to (c) During the 15th Session of the Joint Commission for Economic and Technical Cooperation of India and Iraq, held in Baghdad of 6th & 7th July, 2002, India agreed to consider the Iraq's proposal for setting up and investing in **a** new grass root refinery of 1,50,000 barrels per day (about 7.5 million metric tonnes per annum) capacity in Mosul area of Iraq.

As far as oil exploration activities are concerned, ONGC-Videsh Limited, a 100% subsidiary of Oil & Natural Gas Corporation Limited (ONGC), has signed an exploration and development contract with Oil Exploration Company of the Ministry of Oil, Iraq on 28.11.2000 for the exploration block-8 in the western desert of Iraq.

Petronet LNG Limited, a Joint Venture of four oil PSUs namely Gas Authority of India Ltd., Oil and Natural Gas Corporation, Bharat Petroleum Corporation Ltd.. and Indian Oil Corporation Ltd. are setting up 2.5 million metric tonnes per annum (MMTPA) capacity Liquefied Natural Gas (LNG) terminal at Kochi in Kerala. Most of the pre-project activities, including prequalification of Engineering, Procurement and Construction (EPC) bidders for lumpsum turnkey contract have been completed and statutory clearances, except environment clearance, have been obtained.
