THE MINISTER OF COAL AND MINES (SUSHREE UMA BHARTI): (a) An official of Coal India Limited had handed over certain papers concerning the then GM (Personnel) of Coal India Limited to the Central Vigilance Commission in November, 2001.

- (b) and (c). The official was occupying a post for a long time and as per the transfer policy of Coal India Limited he was transferred.
- (d) Some representations have been received by the Government against this transfer.
 - (e) These are being examined by the concerned authorities.

Discovery of Diamond Mines in Orissa

- 766. SHRI SURENDRA LATH: Will the Minister of COAL AND MINES be pleased to state:
- (a) whether Government have discovered new diamond mines in the State of Orissa;
 - (b) if so, the approximate areas in which diamond mines are located;
 - (c) the steps taken for the proper exploitation of those diamond mines; and
 - (d) the details thereof?

THE MINISTER OF COAL AND MINES (SUSHREE UMA BHARTI): (a) to (d) As per information received from Indian Bureau of Mines (IBM), a subordinate office of Department of Mines, the Directorate of Geology & Mining, Government of Orissa, with United Nations Development Programme (UNDP) technical assistance, undertook exploration for diamond in the parts of Nuapada District, Orissa. During the course of exploration one diamondiferrous kimberlite/Lamproitic body has been discovered near Kalmi-dadar (north west of Dharmabandha) in the northern part of Nuapada. Besides, two altered ultra basic bodies of olivine/lamproite composition have been discovered to the east, near Supali and to south near Pokkanpadar of aforesaid Kalmidadar body. Bulk sampling and processing have ascertained that the Kalmidadar body is diamondiferrous. Besides, applications for grant of Reconnaissance Permits, inter alia, for diamond in Nuapada, Bolangir, Kalahandi and Nawarangpur Districts of Orissa have been accorded prior approval by the central Government.

Misuse of Official telephone

- 768. SHRI JIBON ROY: Will the Minister of COAL AND MINES be pleased to state:
- (a) whether it is a fact that General Manager, Personnel, Coal India Ltd. was found misusing his Official telephones for making international indecent calls;
 - (b) if so, the details thereof and amount involved in misuse;
 - (c) whether Coal India Ltd. enquired into the matter; and
 - (d) if so, the action taken against the concerned official?

THE MINISTER OF COAL AND MINES (SUSHREE UMA BHARTI): (a) to (d) Investigations by Vigilance Department of Coal India Limited revealed that a large number of telephone calls, both STD and ISD were made from the official telephone of the then General Manager (Personnel), Coal India Limited between July, 97 and January, 1998. A recovery of Rs.1,31,171/- was ordered to be realised from the monthly salary of then GM(Pers.) @ Rs-2000/- per month w.e.f November, 1999. A formal disciplinary proceeding was ordered, and, after enquiry, the said officer was found guilty and penalty imposed.
