Re.: Disinvestment of Paradip Phosphates Limited

THE LEADER OF THE OPPOSITION (DR. MANMOHAN SINGH): Mr. Chairman, Sir, this is a matter of urgent public importance and I request you to allow my colleague, Mr. Kapil Sibal, to make his submission.

SHRI KAPIL SIBAL (Bihar): Mr. Chairman, Sir, I rise to raise an issue in respect of the disinvestment of Paradip Phosphates Limited.

I just want to state that the disinvestment process involves entering into a share purchase agreement with a strategic partner in terms of which the sale price is determined and the ultimate adjustment of finances takes place, which is called 'Post-closure adjustment.' In other words, an accountant, who is appointed by the Government, looks at the financial statements, prepares the financial statements and, ultimately, in the post-
