

**Sports Complex in Tamil Nadu**

454. SHRI R. KAMARAJ: Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) whether there is any proposal with Government for construction of sports complexes at Thanjarvur, Thiruvarur and Nagappattinam districts of Tamil Nadu: and

(b) if so, at which places the proposed complexes are to be constructed, alongwith the details of financial allocation made therefor?

THE MINISTER OF STATE IN THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI P. RADHAKRISHNAN) : (a) There is no proposal for construction of sports complex at Thanjarvur. However, proposals for construction of sports complexes at Thiruvarur and Nagappattinam Districts of Tamilnadu have been received.

(b) For the district sports complex at Thiruvarur, Central assistance of Rs.68.00 lakhs has been approved on 18.11.2002. The other proposal of district sports complex at Nagappattinam was approved with Central assistance of Rs. 48.00 lakhs on 21.8.2000.
