**RE. SUPREME COURTS JUDGEMENT ON SYMBOLIC PUJA AT  
AYODHYA- *Con td.***

श्री जनेश्वर मिश्र : महोदया, आज सुबह ही बात हुई थी कि ...(*व्यवधान*)...

SHRI S. RAMACHANDRAN PILLAI: Madam, we raised an important issue in the morning. On behalf of the Government, the Attorney-General had made a request in the Supreme Court to allow the puja by the VHP and the Sangh Parivar. This is in complete variance with the assurance given by the Government representatives in both Houses of Parliament, and it is also in complete variance with the President's Address. It was stated that the Government, being the statutory receiver, is duty-bound to maintain the *status quo* at the disputed site of Ayodhya. It was also stated that the Government would ensure that all necessary measures were taken for the preservation of law and order. After giving these assurances before this House, the Government has gone to the Supreme Court pleading, that the VHP should be permitted to do the puja there. So, this is in complete variance with all the assurances given by the Government. I would like to know from the NDA allies whether the present Government is implementing the VHP Agenda or the NDA Agenda. I would like the Government to come forward and make a statement on this particular issue.

THE DEPUTY CHAIRMAN: I heard, in my Chamber, the Leader of the House saying that the Law Minister would come and make the position clear... *(Interruptions)*...

SHRI N.K. PREMACHANDRAN: It is the Prime Minister who has to respond, not the Law Minister. It is a question of propriety..*(Intenvptions)*...

THE DEPUTY CHAIRMAN: I agree with you. As far as my knowledge goes, - I even confirmed it from the Secretary-General - the Law Minister would *come*..*(Interruptions)*...or whether it is the Prime Minister who would come and say something. I have nothing to comment on that. You have all the right to make a demand, and the Government has to respond to it. But, I believe, - the Leader of the House is here -- he said in the morning, which I heard on the T.V., that the Law Minister would make the position clear..*(Interruptions)*...

SHRI PRANAB MUKHERJEE: We would like to know exactly at what time the statement would be made.

THE DEPUTY CHAIRMAN: The Leader of the House is there. Let him say *something*..*(Interruptions)*...

SHRI GHULAM NABI AZAD (Jammu and Kashmir) : We would like to know whether the Government is intact at all, as some allies have already withdrawn their support..*(Interruptions)*...

श्री मूलचन्द मीणा : प्राइम मिनिस्टर आकर बताएं कि...(व्यवधान)...

उपसभापति : उनको जवाब तो देने दीजिए न।

श्री रमा शंकर कौशिक : महोदया, यह सवाल इसलिए उठता है क्योंकि परसों 15 तारीख है और सरकार की विश्वसनीयता पर प्रश्न चिन्ह लग गया है क्योंकि सरकार दो तरह की बातें कह रही है। वह यहां तो कहते हैं कि हम हर तरह से सुप्रीम कोर्ट के आर्डर को मानेंगे और सुप्रीम कोर्ट में यह प्ली लेते हैं कि उनको पूजा की इजाजत दी जाए। तो मैडम, सवाल

विश्वसनीयता का है। हमारी मांग है कि वहां तत्काल सेना तैनात कर दी जाए क्योंकि न तो हमें सी.आर.पी.एफ. पर भरोसा है और न पी.ए.सी. पर भरोसा है, वैसे ही जैसे इस सरकार पर हमें कोई भरोसा नहीं है। मैडम, ये दो तरह की बोली बोलते हैं। इसलिए वह विश्वसनीयता का प्रश्न है।

**उपसभापति :** देखिए, ऐसा है, I cannot reply on behalf of the Government. I can only convey it to the Leader of the House. The Leader of the House is present here and he wants to say something. So, let us first hear him. It is the Government which will inform the House.

**श्री मूलचन्द मीणा :** मैडम, स्थिति के खराब होने का कारण यह है कि यू.पी. में पहले भी इनकी सरकार थी और इन्होंने सुप्रीम कोर्ट में हलफनामा पेश किया था। उस हलफनामे का क्या हुआ? आज कोर्ट में इनके वकील के माध्यम से इस सरकार की मंशा भी जाहिर हो गई है, इसलिए इस सरकार पर भरोसा नहीं किया जा सकता। इसलिए हम चाहते हैं कि प्रधान मंत्री जी हाऊस में आएँ और बताएं कि हम सुप्रीम कोर्ट की रक्षा कैसे करें?

THE DEPUTY CHAIRMAN: Before I give any judgment - I can't give a judgment - or any ruling or make any comment, I will first give a chance to the Leader of the House, who is present here, to explain. Then, you can react.

**श्री संघ प्रिय गौतम :** मैडम, यह मसला पहले उठ गया था और जवाब भी हो गया था। अब कितनी बार जवाब होगा? ...(व्यवधान)...

SHRI JASWANT SINGH: Madam. I am really... but that is a different matter altogether. I am saddened that what I say in the House is doubted as I find from the phrases the hon. Members use. It is not a very ennobling experience. But, nevertheless, hon. Members are free to doubt my words. माननीय जनेश्वर जी कहें कि मुझे इनकी ज़बान पर भरोसा नहीं है, यह बात चुभती है।...(व्यवधान)...

**श्री जनेश्वर मिश्र :** आपको नहीं कहा। सरकार की ज़बान पर भरोसा नहीं, ऐसा कहा। वह यहां कुछ औ कहे और उनका ऐटर्नी जनरल कुछ और कहे तो क्या हम उस पर भरोसा कर सकते हैं? आपको नहीं कहा गया, गवर्नमेंट के बारे में कहा गया। ...(व्यवधान)...

THE DEPUTY CHAIRMAN: Mr. Nilotpal Basu, let the Leader of the House, who is the representative of the Government, say what he wants to say, and then you can have your "tippani" or whatever your comments are. But let the Government speak first. I cannot speak on behalf of the Government. I can only convey your views to this side and their views to this side. That is what my job is.

SHRI JASWANT SINGH: Madam, in the morning this question was raised soon after, I think, the Question Hour was over. I had made quite explicit the Government's position, that the Government is bound by, and shall abide impeccably by what the Supreme Court has ruled. I also said that I was not present in the court. Therefore, I am not in a position to say what was said in the court. I will however, request the Law Minister to come and inform the House as to what was said in the court. Members are, of course, free to express what views they like to on what I say or fail to say. That is their right, certainly. But, as far as the Government is concerned, there is no ambiguity. We will abide by the court's judgment. The court has said, 'no activity on if, and that is what we will do.
