THE MINISTER OF STATE OF THE MINISTRY OF COAL (SHRI N. T. SHANMUGAM): (a) The details of overall production of coal in the country during the years 1998-99 and 1999-2000 are as under:

(b) to (d) Coal is under Open General Licence (OGL) and coal imports are not monitored by Ministry of Coal. Consumers are importing coal, particularly coking coal and superior quality non-coking coal on account of inadequate availability of such coal from indigenous sources. Import of coal is also resorted to because the present level of customs duty and railway freight make such imports cost competitive per unit of calorific value on certain locations, particularly in the coastal areas.
