**THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV):** (a) to (c) The Government seeks to bestow on the agriculture sector in as many respects as possible benefits similar to those obtaining in the manufacturing sector, such as easy availability of credit and other inputs and infrastructure facilities for development of agri-business industries and development of effective delivery system and freeing movement of agro-produce.

#### **Co-operative societies in Arunachal Pradesh**

(b) The National Co-operative Development Corporation (NCDC) has released financial assistance of Rs.13.90 Lakh, Rs.24.45 lakh and Rs.258.15 lakh during the years 1998-99, 1999-2000 and 2000-2001 respectively to the State of Arunachal Pradesh under the activities for marketing, storage, Integrated Co-operative Development Projects (ICDP) and weaker sections for tribal and handlooms. Likewise the State Government has also provided financial assistance as given in statement - I (see below)
