Relief and rehabilitation of victims of Gujarat Earthquake

173. SHRI KRISHNA KUMAR BIRLA: Will the Minister of AGRICULTURE be pleased to state:

(a) whether the Indian People's Tribunal on Environment and Human Rights, which inquired into the relief and rehabilitation work for Gujarat earthquake has passed severe strictures on the functioning of the Gujarat Government for its apathy and discrimination against the minority community in carrying out the relief and rehabilitation programme;

(b) if so, what are the details thereof; and

(c) what steps have been taken by Government in this regard?

Subsidy for wheat and paddy producing countries

SHRI RAJIV RANJAN SINGH 'LALAN':

Will the Minister of AGRICULTURE be pleased to state:

(a) whether it is a fact that America and other wheat and paddy producing countries of the world are giving such amounts of subsidy for their agricultural produces which are violating the conditions prescribed by the World Trade Organization;

(b) if so, the details of Government's information in this regard;

(c) whether Government have provided such information to the officials of World Trade Organization and requested them to take action in this regard; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV): (a) to (d) The WTO Agreement on Agriculture mandates disciplines in the areas of Market Access, Domestic Support and Export Subsidies. Through an established procedure of annual notifications, Members indicate the implementation of their commitments under the Agreement on Agriculture. As there is a time lag in filing these notifications in the WTO, the final compilation of implementation of commitments is not complete as yet. The implementation of these commitments is also reviewed by Members in the regular Committee on Agriculture meetings of the WTO. India has been in the forefront in demanding that implementation related concerns of the developing countries regarding the WTO agreements should be resolved satisfactorily. The implementation concerns broadly relate to inequities and imbalances in the existing WTO agreements, non-realization of anticipated benefits from the WTO agreements and the non-operational and non-binding nature of most of the Special and Differential (S&D) provisions in favour of developing countries. The implementation related concerns were highlighted by India through its proposals, which were co-sponsored by 11 other like-minded group of countries. After the Doha Ministerial Conference, these issues have become an integral part of WTO work programme.
