**Kendriya Vidyalayas in Pucca Buildings**

**†962. DR. A.K. PATEL:** Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to answer to Unstarred Question 3504, given in the Rajya Sabha on 25th August, 2000 and state:

(a) the number of Kendriya Vidyalayas running in tents which have been shifted in pucca buildings by Government till 1st January, 2002, State-wise; and

(b) by when remaining Kendriya Vidyalayas would be shifted in pucca buildings?

**THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. (SHRIMATI) RITA VERMA):** (a) and (b) The reply given to Unstarred Question No. 3504 was in respect of schools being run in tin sheds and not in respect of schools being run in tents. However, after 25th August, 2000 the date on which Unstarred Question No. 3504 was answered no school functioning in tents have been shifted to Pucca Building. At present only following two schools are functioning from tents:

(1) *Pragati Vihar, Lodhi Road, New Delhi.*—It is running partly in tents. Permanent school building Kendriya Vidyalaya in under construction.

(2) *No. 2 Army Bhuj, Gujarat.*—It is being run tents as the
