## Allotment of NCC Units to Sainik Schools of Maharashtra

- 4410. SHRI SATISH PRADHAN: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that Union Government has been requested by the State Government of Maharashtra for the allotment of NCC Units to 16 Sainik Schools of Maharashtra; and
- (b) if so, Government's response thereto and steps taken for providing NCC Units to the 16 Sainik Schools of Maharashtra?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) No, Sir. The only Sainik School in the State of Maharashtra, at Satara run by Sainik School Society, Ministry of Defence, is already under NCC cover.

(b) All road projects are successfully implemented by BRTF as per targets and availability of funds.

(c) and (d) There is no proposal to increase the number of BRTF. The present strength is more than needed for the General Staff road works. The spare capacity is being used for doing the Agency works. BRO's endeavour is to enhance the output of organization with the existing manpower, with the help of greater mechanization and use of upgraded construction equipments.
