(d) what is the minimum time taken by the Ministry to settle the claims?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI A. RAJA): (a) and (b) The list of medical reimbursement claims of Government pensioners which could not be cleared by 31st March, 2002 in respect of each of the CGHS covered cities is given in the Annexure. [See Appendix 195, Annexure No. 46]

The delay in settlement of medical claims of Government pensioners by the CGHS is primarily due to non-availability of funds during the months of February and March *i.e.* at the end of the financial year.

(c) Subject to the claims pending as on 31.3.2002 being complete in all respects, they would be cleared within a month's time.

(d) Except in cases where special approvals have to be obtained for some medical claims, it normally takes about four to six weeks for the CGHS to settle the medical claims of the Government pensioners provided the pensioners have furnished all the required documents and subject to the condition that necessary funds are available with the CGHS.

THE MINISTER OF DEVELOPMENT OF NORTH EASTERN REGION (SHRI ARUN SHOURIE): (a) and (b) As on 24.4.02 there are 32 road schemes of

NEC, which are under construction in the North East. State-wise list of these roads with scheduled dates of completion is at Statement (See below).

(c) The Annual Plan 2002-2003 and the Tenth Five Year Plan which contain *inter-alia*, proposals for new roads have not as yet been finalised by the Planning Commission. Priority will be accorded to completing the schemes that are under construction.

Development of Dhodar Ali Road

4799. SHRI DRUPAD BORGOHAIN: Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:

(a) whether North-Eastern Council has allotted fund for the development of Dhodar Ali Road from Deberapar of Jorhat district to Jeypore of Dibrugarh district for the year 2002-2003;

(b) if so, the amount allocated therefor;

(c) whether there is any time-frame to complete the construction of all bridges now half done and road improvement that remain of the other half of Dhodar Ali Road from Kumargaon of Golaghat district to Deberapar of Jorhat district; and

(d) the cause of this delay though the money was sanctioned in 1989?

THE MINISTER OF DEVELOPMENT OF NORTH EASTERN REGION (SHRI ARUN SHOURIE): (a) and (b) North Eastern Council has provided Rs. 9 crores for the Development of 100 kms. in various stretches on the Dhodar Ali Road including that from Deberapar (in Jorhat district, Assam) to Jeypore (in Dibrugarh district, Assam) during the year 2002-03.

(c) 12 bridges on the various stretches of Dhodar Ali Road have been taken up for improvement by NEC. The bridges are planned to be completed by March, 2003. Road improvement of the stretches on the other part of the Dhodar Ali Road, i.e. Kumargaon (in Golaghat district, Assam) to Deberapar (in Jorhat district, Assam) are also planned for completion by March, 2003, except for a small stretch of 5 kms. from km. 28 to km. 32, which will spill over beyond March, 2003. The rescheduled date of completion of project is 2005.
