

Spur in STD traffic

1205. SHRI NANA DESHMUKH: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

(a) whether it is a fact that recent cut in telecom tariffs has spurred the STD traffic;

(b) whether it is also a fact that Bharti's rate cut has also been made effective from 26th January, this year; and

(c) If so, the percent of increase in metered call units because of both the cuts?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI TAPAN SIKDAR): (a) and (b) Yes, Sir.

(c) Although the traffic is BSNL (Bharat Sanchar Nigam Limited) has increased by about 25 per cent after the reduction in STD rated, there has been a decrease by about 20 per cent in the long distance metered call units as per a sample study conducted in the month of February, 2002.

(ii) M/s North East Online Service Pvt. Ltd.

(iii) M/s Trans Virtual Ltd.

(e) All District Headquarters have been provided with Internet Services by BSNL. Details of internet service providers, who have set up their internet nodes in Assam are given in the Statement.

(a) the revenue earned by VSNL from international long distance telephony during the last three financial years, year-wise;

(b) the revenue earned by BSNL and erstwhile DoT during the corresponding years from carrying ILD traffic as NLD carriers and circle operators, year-wise;

(c) whether BSNL would now have to depend on VSNL for international long distance incoming traffic;

(d) whether VSNL itself has NLD licence and this puts BSNL at a disadvantage in getting incoming ILD traffic;

(e) if so, whether Government's action for not allowing BSNL to bid for VSNL is discriminatory; and

(f) if not, the reasons therefor?
