Capacity expansion of telephone exchanges in U.P. and Haryana

*729. SHRI HARENDRA SINGH MALIK: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

(a) whether Government propose to expand capacity of the existing telephone exchanges by providing modern communication facility in Uttar Pradesh and Haryana during the year 2002-2003;

(b) if so, the details thereof, district wise; and

(c) the funds provided by Government for the said period?

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI PRAMOD MAHAJAN): (a) to (c) State of art digital

electronic exchanges are already available in Uttar Pradesh and Haryana. The district-wise details of expansion of net switching capacity of the existing telephone exchanges in Uttar Pradesh and Haryana are given in the Statement. (See below) Modern communication facilities are available in a large number of districts. Action is in hand to cover majority of the remaining districts during the current year.

Funds have so far been allotted for only first two months of the financial year to the extent of Rs. 221.46 crores & Rs. 54.40 crores for Uttar Pradesh and Haryana respectively. Action is in hand for allocating funds for remaining ten months.

**Human development report regarding growth
and development**

*730. SHRI P. PRABHAKAR REDDY:
SHRI KARNENDU BHATTACHARJEE:

Will the PRIME MINISTER be pleased to state:

(a) whether Government's attention has been drawn to the news-item captioned "Graft stunts growth: H.D. report" appearing in the Hindustan Times dated the 24th April, 2002; and

(b) the steps proposed to be taken to address the problems highlighted in the report which have hampered growth and development in the country?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRIMATI VASUNDHARA RAJE): (a) and (b) Yes, Sir. The National Human Development Report (NHDR)-2001 prepared by the Planning Commission has been released by the Prime Minister of April 23rd, 2002. The Report maps the state of human development and the quality of life in terms of changes in a range of indicators that have been tracked across States at different points of time over the period 1980 to 2001. While the Report gives the status of human development in the country and highlights the importance of addressing various issues of governance with a view to improve the outcome of the development process, it would devolve on the Plans of both Centre and States to address the various concerns that have been highlighted in the NHDR. Presently, the Tenth Plan is in advance stage of finalisation.
