

programmes and schemes. The implementation of the Central schemes/programmes for development of small scale industries has supplemented the growth of SSI and tiny sector in many ways as evident from the increase in the number of registered units in this sector from 24.06 lakhs in 1998-99 to 26.72 lakhs (projected) in 2000-01. The investment in this sector during 1998-99 which was Rs. 77531 crore has gone up to Rs. 89276 crore in 2000-01. The employment generated has shown an increase from Rs. 171.58 lakhs in 1998-99 to Rs. 185.64 lakhs in 2000-01. The export has gone up from Rs. 48979 crore to Rs. 59978 crore during this period. Besides these, under various programmes 85776 persons have undergone training in different fields during the last three years. Similarly, under PMRY a total number of 6,03,142 cases have been sanctioned during this period.

Soft loan facilities to SSI Sector

THE MINISTER OF STATE OF THE MINISTRY OF SMALL SCALE INDUSTRIES (SHRIMATI VASUNDHARA RAJE): (a) No, Sir.

(b) The Small Industries Development Bank of India (SIDBI) extends soft loan facilities to small scale industries located throughout the country through Primary Lending Institutions which have a countrywide network of branches.

Perfume factories in Madurai

THE MINISTER OF STATE OF THE MINISTRY OF SMALL SCALE INDUSTRIES (SHRIMATI VASUNDHARA RAJE): (a) to (c) The Government of Tamil Nadu has intimated that since cultivation of flowers in Madurai district is not sufficient, presently no entrepreneur has exhibited interest in setting up of perfume factories.

Macro Satellite Project by ISRO and Anna University

5396. SHRIMATI VANGA GEETHA: Will the PRIME MINISTER be pleased to state:

- (b) whether ISRO and Anna University, Chennai have tied up for macro satellite project;
- (c) if so, the details thereof;
- (d) the time frame fixed for the project to be completed; and
- (e) the cost of the project?

THE MINISTER OF STATE IN THE DEPARTMENT OF SPACE (SHRIMATI VASUNDHARA RAJE): (a) and (b) Yes, Sir. Under this agreement, Anna University will build a macro satellite with necessary technical and managerial guidance from Indian Space Research Organisation (ISRO). The macro satellite weighing around 60 kgs. is expected to carry a store and forward communication payload.

- (c) The satellite will be developed in about 3 years.
- (d) The overall project cost is estimated to be around Rs. 5.50 Crores, of which, assistance from ISRO will be about Rs. 4.00 Crores.
